- 7. Use absorbent or kitty litter to clean your parking lot instead of a pressure washer.
- 8. Pick up all litter, trash, or debris outside your facility surface coating operations. daily and keep lids on all trash receptacles.
- 9. Send all dirty rags to a laundry service. Never wash oily rags at your home or anywhere without an approved sand/grit trap or oil/water separator.



10. Have a spill response plan and keep spill cleanup materials nearby.

## The Dos and Don'ts of Vehicle Washing

In Texas, you must have an air authorization to paint automobiles. Certain rules also apply to how you manage your waste. The following information is for small auto body shops.

**Got Paint?** 

Why is the state regulating small auto body shops? The air pollution from your individual shop may be small. However, the overall pollution from all the 6,000 auto body shops all over the state is huge. If you are already operating, you need to follow these rules or apply for an air permit as soon as possible. It is a violation of state law to operate without having a permit or following the rules.

Do I have to have an enclosed paint booth? If your shop uses two gallons or more of paint and solvents in any week, you must have an enclosed, filtered paint booth or enclosed, filtered spray area. What can I do to meet the "less than 1/2 pint per hour" limit?

To fit into this smallest category of shop, you must use less than 1/2 pint or less of paint in any one hour of operation. This category is for shops that only do detail work and small touch-up jobs to operate without registering. Remember, whether you register or not, you should keep records for at least 2 years. I think my shop is "Grandfathered." Do I still need

to comply? It does not matter how long you have been in business, everyone needs to follow the rules.

## Do I have to keep records?

Yes. Keep records for at least 2 years. When your shop is inspected, you need to be able to show you are following the rules. You should keep the follow-

- MSDS sheets
- Solvent and paint purchase records
- Monthly paint and solvent usage
- Amount and type of waste generated.

What if I cannot follow all the requirements? You may change your practices or equipment to meet the requirements. If this is not practical for your shop, you may apply for an air permit.

What happens if I don't follow these rules or have a permit?

\$10,000 for each day you are in violation of Texas DON'T allow washing wastewater to go into rules. If you need help understanding what is required for your shop, contact the TCEQ Small Business and Local Government Assistance Program at 1-800-447-2827.

The City of Grand Prairie does not allow vehicle wash water from businesses to enter storm sewers. Storm sewers drain directly into nearby creeks, streams, and lakes.

## **GREATEST RISKS**

‡ Vehicle washing wastewater can pollute drinking water or streams and

lakes and you could be held responsible.

## **BEST FIXES**

#### **Indoor Washing:**

- ‡ If you drain to the sanitary sewer system, you must use an approved oil/ water separator or sand/grit trap.
- ‡ If you are not connected to the City sewer and are using an aerobic or septic system, the discharge of chemicals is prohibited and you must find an alternative location to discharge the chemicals.

## **Outdoor Washing:**

- ‡ Outdoor washing is prohibited without an approved washbay.
- ‡ Allowing wastewater to go to the sanitary sewer through a sand/grit trap must be done at an approved facility. This may be done at a commercial car wash only if there is an agreement with the commercial car wash operator. A copy of the agreement must be available to show City staff.
- ‡ Only automotive sales facilities can use plain water without collecting the wastewater. However, NO SOAPS OR DEGREASERS are allowed.

#### VEHICLE WASHING DOS AND DON'TS

- DO check each vehicle for leaking fluids before washing it. Use drip pans or absorbents (e.g. kitty litter) to collect leaking fluids.
- ‡ DO use oil/water separators or sand/grit traps to remove dirt and oils from vehicle The TCEQ has authority to assess penalties of up to washing wastewater.
- water bodies, storm drains, sewer pipes, septic tanks, or onto the ground.
