GRAND PRAIRIE MAIN STREET ROUNDABOUT

From State Highway (SH) 180 (Main Street) to Jefferson Street

The Texas Department of Transportation (TxDOT) and the City of Grand Prairie are proposing to reconstruct the existing at-grade intersection of East Main Street and East Jefferson Street to an atgrade, highspeed, multi-lane roundabout in Dallas County, Texas. This notice advises the public that TxDOT is affording an opportunity for a public hearing on the proposed project.

The project limits span across four intersections including East Main Street and East Jefferson Street; East Main Street and Service Road North; East Jefferson Street and Service Road South; and East Jefferson Street and Idlewild Road. The proposed project would reduce East Jefferson Street (westbound) to one lane approaching the East Main Street intersection, with the existing right lane converted to a right turn only lane. Additionally, the existing East Jefferson Street (eastbound) two left turn lanes would be shifted east to for the northbound roundabout approach. Service Road South would be reconstructed to remove the intersection with East Jefferson Street and converted into a cul-de-sac. Similarly, Service Road North would be reconstructed to remove the intersection with East Main Street and converted into a cul-de-sac.

Additional improvements include the construction of a 10-foot-wide sidewalk along East Main Street and Service Road North, East Main Street and East Jefferson Street, and East Jefferson Street and Service Road South. Pedestrian crossings would also be included across East Main Street (westbound) and across East Main Street (eastbound) and East Jefferson Street. The existing right-of-way varies between 100 feet to 546 feet in width. No additional right-of-way would be required for the construction of the proposed project.

The proposed project would involve construction in wetlands.

The proposed project would involve an action in a floodplain.

Any environmental documentation or studies, maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the City of Grand Prairie located at 300 W Main Street, Grand Prairie, TX 75050, and by calling (972) 237-8132.
