CALL TO ORDER – Mr. King called the meeting to order at 6:31 p.m.

COMMISSIONER APPOINTMENTS –

REVIEW OF MINUTES FROM July 2019 – Mr. Hall made a motion to approve the minutes as written. Ms. Stevenson seconded the motion and it passed 6-0.

KEEP AMERICA BEAUTIFUL YLAC SUMMARY – Ms. Lindbergh shared that she is one of eight affiliate leaders from around the country that was appointed to the first Keep America Beautiful Young Leaders Advisory Council. She met with the KAB staff and YLAC in August at the KAB office in Connecticut. YLAC was asked for ways to make KAB relevant and better known. One of the ideas was a YouTube channel called "Minutes with Affiliates," in which affiliates can submit a video about an event or program that they are working on. Another was to have a sponsor spotlight which would provide an opportunity for KAB sponsors to highlight their relevant work in the community.

MARKETING OF KGPB – Ms. Lindbergh provided examples of new KGPB marketing including a mini auto trash can, super dry cooling towel, and logoed cleanup gloves. She will proceed with getting a quote for the items and ordering before the next meeting.
