Applications for ballots by mail (ABBM) and Federal Post Card Applications (FPCAs) must be received no later than the close of business on June 2, 2026. If an application for ballot by mail is faxed or emailed, the voter must submit the ORIGINAL signed application to the Early Voting Clerk of the county elections department as listed above so that they may receive the original no later than the 4<sup>th</sup> business day after receiving the emailed or faxed application for ballot by mail.

The last day to register to vote in the June 13, 2026, election is May 14, 2026.
