PROPOSITION A

The reauthorization of the local sales and use tax in the City of Grand Prairie, Texas, at the rate of one-fourth of one percent to continue providing revenue for maintenance and repair of municipal streets. The tax expires on the eighth anniversary of the date of this election unless the imposition of the tax is reauthorized.

Shall the City of Grand Prairie City Charter provision Article IV, Section 11, be amended to add deputy mayor pro tem, who shall be selected from among the members of the council and shall perform all duties of the mayor in the mayor pro tem’s absence or disability?

If approved by a majority of the qualified voters, Article IV Section 11 would read as follows:

Sec. 11. Mayor pro tem; deputy mayor pro tem.

The mayor pro tem shall be selected from among the members of the council and shall perform all duties of the mayor in the mayor's absence or disability. The deputy mayor pro tem shall be selected from among the members of the council and shall perform all duties of the mayor in the mayor pro tem's absence or disability.

PROPOSITION C

Shall the Grand Prairie City Charter be amended to remove any redundancies or inconsistencies, correct any typographical errors, make any necessary language gender neutral, and remove or modify any language that conflicts with or is preempted by other state or federal law?

Applications for ballots by mail (ABBM) and Federal Post Card Applications (FPCAs) must be received no later than the close of business on April 22, 2025.

If an application for ballot by mail is faxed or emailed, the voter must submit the ORIGINAL signed application to the Early Voting Clerk of the county elections department as listed above, so that they may receive the original no later than the 4th business day after receiving the emailed or faxed application for ballot by mail.

The last day to register to vote in the May 3, 2025, election is April 3, 2025.


