The main goal of these programs is to develop urban communities which are free of slums, deterioration, and conditions which are detrimental to health, safety, and public welfare. Federal money is available to help maintain housing, provide more economic opportunities for low- and moderate-income households, improve community services, and provide for a greater diversity and vitality of neighborhoods. Other important uses of these funds are for the more rational utilization of land and natural resources, and the preservation of areas with historical significance.

Eligible activities for CDBG funding include:

- 1. Purchase and/or sale of land and buildings which:**
 - a. Are blighted, undeveloped or inappropriately developed
 - b. Can be brought to standard condition
 - c. Are needed for public works projects
 - d. Are needed for other public purposes
- 2. Construction or installation of public works facilities**
- 3. Code enforcement in deteriorating areas.**

4. **Clearance, demolition, and rehabilitation of buildings, and payments for temporary housing of people displaced by community development activities.**
5. **Special projects to assist the mobility of the elderly and handicapped**
6. **The provision of public services is not otherwise available if:**
 - a. They support other approved activities
 - b. Aid to provide such services has been denied under other federal programs
7. **Payment of local share for federal grants**
8. **Activities necessary to develop a comprehensive plan for community development and housing activities**
9. **Payment of reasonable administrative costs related to community development activities**

Eligible activities for the HOME programs include Community Housing Development Organization (CHDO's), occupied and rental housing rehabilitation, housing reconstruction, tenant-based assistance, and home ownership projects.

Activities of general governmental support, such as construction of city halls, libraries, or schools are not allowed.
