

City Water Rates

Sec. 26-29. - Raw water rates.

Untreated water taken from the city's contracted water rights in Joe Pool Lake shall be metered by a meter approved by the director of public works or designee and charged at nine dollars and twenty-seven cents (\$9.27) per one thousand (1,000) gallons and a monthly administration fee of one hundred thirty-eight dollars and forty-three cents (\$138.43).

Sec. 26-30. - Water taken from fire hydrants.

Water taken from the city's fire hydrants, other than that used by the various municipal departments for authorized purposes such as firefighting, street cleaning and system flushing, shall be metered by an approved meter obtained from the public works department, possessing a City of Grand Prairie logo and backflow prevention device. A refundable deposit of two thousand five hundred dollars (\$2,500.00) shall be charged. Water taken from fire hydrants shall be charged at a rate of nine dollars and twenty-seven cents (\$9.27) per one thousand (1,000) gallons and a monthly administration fee of one hundred thirty-eight dollars and forty-three cents (\$138.43).
