d. Property Tax/Fund Status Update

Gary Yakesch presented a report on the Parks Department Property Tax and Fund Status

A Fund is an accounting entity with a self-balancing set of accounts to carry out a specific activity.

- Contain statutory and/or fiduciary restrictions.
- Focuses on accountability rather than profitability.
- Sources and Uses
 - Revenues & Expenditures (Profit Accounting)
 - Resources & Appropriations (Fund Accounting)

Fund Types:

- General Prop Tax; PD, Fire, PW, Administration, Parks, Services to citizens (our bosses)
- Special dedicated purpose ¼ Parks, ¼ Streets can't use streets for parks can't use Parks for PD etc.
- Capital typically funded from other fund reserves and/or bonded debt
- Debt Service Bonded Debt Ties to Property Tax Rate two components I&S and M&O
- Enterprise these funds pay their own way
- Internal Service take all expenditures and allocate proportionately to departments/funds
- Trust dedicated/specific
- Grants Statutory and/or private regulations transparency and routine reporting

GENERAL FUND & PROPERTY TAX

General Fund Revenues

Ad Valorem Tax-The General Fund's largest revenue source is the ad valorem tax. The operations and maintenance (O&M) portion of the tax rate is 0.457128 per \$100 of

valuation, and assuming a collection rate of 99.5% the City should receive \$73,253,578 in current taxes. When delinquent taxes and interest of \$210,270 is included, minus the revenue lost to the TIF of \$2,321,005, the resulting ad valorem related collections for 2019-20 is forecasted to be \$71,142,843.
