
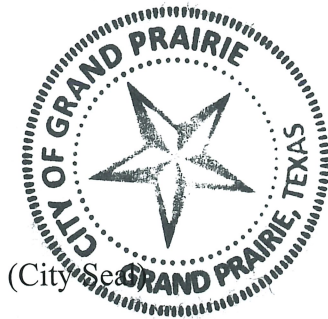

AN ORDINANCE CALLING A BOND ELECTION TO BE HELD IN THE CITY OF GRAND PRAIRIE, TEXAS; MAKING PROVISION FOR THE CONDUCT OF AN ELECTION; AND RESOLVING OTHER MATTERS INCIDENT AND RELATED TO SUCH ELECTION

* * * * *

WHEREAS, the City Council (the “Council”) of the CITY OF GRAND PRAIRIE, TEXAS (the “City”), located in Dallas County, Johnson County, Ellis County and Tarrant County, Texas, hereby finds and determines that an election should be held on May 2, 2026, to determine whether the Council shall be authorized to issue general obligation bonds of the City in the amounts and for the purposes hereinafter identified (the “Election”); and

WHEREAS, the City will enter into election services contracts with the Dallas County Elections Administrator, the Ellis County Elections Administrator and the Tarrant County Elections Administrator (each, an “Elections Administrator,” and together, the “Elections Administrators”), in accordance with the provisions of Subchapter D of Chapter 31, as amended, Texas Election Code, or other applicable law, pursuant to which the Elections Administrators will assist with certain aspects of the Election on the City’s behalf;

WHEREAS, the Council hereby finds and determines that it is in the public interest to call and hold the Election at the earliest possible date to authorize the issuance of general obligation bonds for the purposes hereinafter identified; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS THAT:

SECTION 1. The Election shall be held in the CITY OF GRAND PRAIRIE, TEXAS on the 2nd day of May, 2026 (“Election Day”), which is a uniform election date under the Texas Election Code, as amended, and is not less than 78 days nor more than 90 days from the date of the adoption of this ordinance (the “Ordinance”), for the purpose of submitting the following propositions to the qualified voters of the City:

CITY OF GRAND PRAIRIE, TEXAS PROPOSITION A
THIS IS A TAX INCREASE

“SHALL the City Council of the City of Grand Prairie, Texas be authorized to issue general obligation bonds of the City in the aggregate principal amount of \$209,500,000 for the purpose of designing, constructing, renovating, improving, expanding, and enhancing all or a portion of the following nonresidential, main thoroughfares, streets, roads, bridges, and intersections:

- Lake Ridge Parkway Bridge and Pedestrian Crossing from south of Lynn Creek to South City Limit;
- West and East Shady Grove Roads from Roy Orr Boulevard to North Belt Line Road;
- West Jefferson Street from South Great Southwest Parkway to Southeast 14th Street;
- West and North Carrier Parkway from State Highway 161 to State Highway 360;

- Roy Orr Boulevard from North Carrier Parkway to Irving City Limits;
- West Westchester Parkway from South Carrier Parkway to Robinson Road;
- Southwest 3rd Street from West Phillips Court to West Main Street;
- South Carrier Parkway from West Jefferson Street to Dickey Road;
- W.E. Roberts Street from Southwest 14th Street to South Great Southwest Parkway;
- West and East Tarrant Roads from Duncan Perry Road to Northeast 15th Street;
- North Carrier Parkway from Dalworth Street to Hill Street; and
- West and East Marshall Roads from Southeast 14th Street to Arlington City Limits;

including associated sidewalks, pedestrian and bicycle access, screening walls, streetscape, signage, beautification, accessibility improvements, traffic controls, street lighting, necessary or incidental utility replacement and relocation, drainage improvements in connection with the foregoing, and the purchase of land, easements, rights-of-way, and other real property interests necessary therefor or incidental therewith;

such bonds to mature serially or otherwise over a period not to exceed forty (40) years from their date of issuance, to be sold in one or more series at any price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise) as shall be determined within the discretion of the City Council under laws in effect at the time of issuance; and shall the City Council be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes, within the limitations prescribed by law, on all taxable property in the City sufficient to pay the annual interest on the bonds and to create a sinking fund to pay the bonds at maturity and to pay the cost of any credit agreements executed in connection with the bonds?"

CITY OF GRAND PRAIRIE, TEXAS PROPOSITION B
THIS IS A TAX INCREASE

“SHALL the City Council of the City of Grand Prairie, Texas be authorized to issue general obligation bonds of the City in the aggregate principal amount of \$78,500,000 for designing, acquiring, constructing, renovating, improving, expanding, and equipping certain public safety facilities and technology infrastructure, to wit: replacing the North Radio Tower located on 109th Street, designing, constructing, and equipping a multipurpose, public safety facility in the southern portion of the City, acquiring and installing a traffic safety communication network, and the purchase of land, easements, and rights-of-way necessary therefor or incidental therewith; such bonds to mature serially or otherwise over a period not to exceed forty (40) years from their date of issuance, to be sold in one or more series at any price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise) as shall be determined within the discretion of the City Council under laws in effect at the time of issuance; and shall the City Council be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes, within the limitations prescribed by law, on all taxable property in the City sufficient to pay the annual interest on the bonds and to create a sinking fund to pay the bonds at maturity and to pay the cost of any credit agreements executed in connection with the bonds?"

CITY OF GRAND PRAIRIE, TEXAS PROPOSITION C
THIS IS A TAX INCREASE

“SHALL the City Council of the City of Grand Prairie, Texas be authorized to issue general obligation bonds of the City in the aggregate principal amount of \$39,000,000 for designing, acquiring, constructing, expanding, improving and equipping certain parks and recreational facilities, to wit: designing, acquiring, constructing, and equipping a new community multi-purpose center, new pickleball courts and facilities, a new, public botanical garden, and acquiring and installing public art for park and recreation lands or facilities, and the purchase of land, easements, rights-of-way, and other real property interests necessary therefor or incidental therewith; such bonds to mature serially or otherwise over a period not to exceed forty (40) years from their date of issuance, to be sold in one or more series at any price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise) as shall be determined within the discretion of the City Council under laws in effect at the time of issuance; and shall the City Council be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes, within the limitations prescribed by law, on all taxable property in the City sufficient to pay the annual interest on the bonds and to create a sinking fund to pay the bonds at maturity and to pay the cost of any credit agreements executed in connection with the bonds?”

SECTION 2. Pursuant to an agreement to be entered into with the Dallas County Elections Department for that portion of the City located in Dallas County, the Ellis County Elections Department for that portion of the City located in Ellis County, and the Tarrant County Elections Department for that portion of the City located in Tarrant County, the Election shall be conducted by the Dallas County Elections Department, the Ellis County Elections Department, and the Tarrant County Elections Department, respectively, in accordance with the provisions of the respective agreements for election services (together, the “Contracts”).

The polling places for this Election are shown in **Exhibit A**, which is attached hereto and incorporated herein by reference as a part of this Ordinance for all purposes. **Exhibit A** shall be modified to include additional or different Election Day polling places designated by the Elections Administrators and to conform to the Contracts. The election officers and maximum number of clerks for each polling place shall be determined and appointed in accordance with the Contracts.

On Election Day, the polls shall be open from 7:00 a.m. to 7:00 p.m.

SECTION 3. With respect to that portion of the City located in Dallas County, the locations, dates and times for early voting for this Election shall be as shown in **Exhibit B**, which is attached hereto and incorporated herein by reference as a part hereof for all purposes. Paul Adams, Dallas County Elections Administrator, is hereby appointed early voting clerk and shall appoint and designate deputy clerks at such early voting polling place in accordance with the agreement with the Dallas County Elections Department.

With respect to that portion of the City located in Ellis County, the locations, dates and times for early voting for this Election shall be as shown in **Exhibit B**, which is attached hereto and incorporated herein by reference as a part hereof for all purposes. Jana Onyon, Ellis County Elections Administrator, is hereby appointed as early voting clerk and shall appoint and designate

deputy clerks for early voting in accordance with the agreement with the Ellis County Elections Department.

With respect to that portion of the City located in Tarrant County, the locations, dates and times for early voting for this Election shall be as shown in **Exhibit B**, which is attached hereto and incorporated herein by reference as a part hereof for all purposes. Clint A. Ludwig, Tarrant County Elections Administrator, is hereby appointed as early voting clerk and shall appoint and designate deputy clerks for early voting in accordance with the agreement with the Tarrant County Elections Department.

For purposes of processing ballots cast in early voting, the election officers for the early voting ballot board for this Election shall be appointed and designated in accordance with the provisions of the Contracts.

SECTION 4: With respect to voters of the City residing in Dallas County, the Central Counting Station for the tabulation and counting of ballots for this Election shall be located at the Office of the Elections Department, 1520 Round Table Drive, Dallas, Texas and the Manager, Tabulation Supervisor, Presiding Judge and Alternate Presiding Judge at such Central Counting Station shall be determined, appointed and designated in accordance with the Contract with the Dallas County Elections Department. The Manager and Presiding Judge of such Central Counting Station may appoint clerks to serve at such Station, as provided by Texas Election Code, Section 127.006, as amended.

With respect to voters of the City residing in Ellis County, the Central Counting Station for the tabulation and counting of ballots for this Election shall be located at the Ellis County Elections Department, 204 E. Jefferson Street, Waxahachie, Texas and the Manager, Tabulation Supervisor, Presiding Judge and Alternate Presiding Judge at such Central Counting Station shall be determined, appointed and designated in accordance with the Contract with the Ellis County Elections Department. The Manager and Presiding Judge of such Central Counting Station may appoint clerks to serve at such Station, as provided by Section 127.006 of the Election Code, as amended.

With respect to voters of the City residing in Tarrant County, the Central Counting Station for the tabulation and counting of ballots for this Election shall be located at the Tarrant County Elections Department, 2700 Premier Street, Fort Worth, Texas and the Manager, Tabulation Supervisor, Presiding Judge and Alternate Presiding Judge at such Central Counting Station shall be determined, appointed and designated in accordance with the Contract with the Tarrant County Elections Department. The Manager and Presiding Judge of such Central Counting Station may appoint clerks to serve at such Station, as provided by Section 127.006 of the Election Code, as amended.

SECTION 5. The official ballot shall be prepared in accordance with the Texas Election Code, as amended, so as to permit voters to vote "FOR" or "AGAINST" the aforesaid propositions which shall appear on the ballot substantially as follows:

THIS IS A TAX INCREASE

“The issuance of \$209,500,000 general obligation bonds for designing, constructing, renovating, improving, expanding, and enhancing all or a portion of the following nonresidential, main thoroughfares, streets, roads, bridges, and intersections:

- Lake Ridge Parkway Bridge and Pedestrian Crossing from south of Lynn Creek to South City Limit;
- West and East Shady Grove Roads from Roy Orr Boulevard to North Belt Line Road;
- West Jefferson Street from South Great Southwest Parkway to Southeast 14th Street;
- West and North Carrier Parkway from State Highway 161 to State Highway 360;
- Roy Orr Boulevard from North Carrier Parkway to Irving City Limits;
- West Westchester Parkway from South Carrier Parkway to Robinson Road;

and the imposition of a tax sufficient to pay the principal of and interest on the bonds and the cost of any credit agreements”

CITY OF GRAND PRAIRIE, TEXAS PROPOSITION B
THIS IS A TAX INCREASE

“The issuance of \$78,500,000 general obligation bonds for public safety facilities and technology infrastructure, specifically, replacing the North Radio Tower located on 109th Street, designing, constructing, and equipping a multipurpose, public safety facility in the southern portion of the City, and acquiring and installing a traffic safety communication network, and the imposition of a tax sufficient to pay the principal of and interest on the bonds and the cost of any credit agreements”

CITY OF GRAND PRAIRIE, TEXAS PROPOSITION C
THIS IS A TAX INCREASE

“The issuance of \$39,000,000 general obligation bonds for certain parks and recreational facilities and related improvements, specifically, a new community multi-purpose center, new pickleball courts and facilities, a new, public botanical garden, and the acquisition and installation of public art for park and recreation lands or facilities, and the imposition of a tax sufficient to pay the principal of and interest on the bonds and the cost of any credit agreements”

SECTION 6. All resident qualified voters of the City shall be permitted to vote at the Election, and on Election Day, such voters shall vote at the designated polling places. The Election shall be held and conducted in accordance with the laws of the State of Texas, including the provisions of the Texas Election Code, as amended, the Texas Government Code, as amended, including Chapter 1251 and as may be required by any other law. To the extent required by law, all materials and proceedings relating to the Election shall be printed in English, Spanish, and Vietnamese.

SECTION 7. Notice of election, including Spanish and Vietnamese translations thereof, shall be published on the same day in each of two successive weeks in a newspaper of general circulation in the City, the first of these publications to appear in such newspaper not more than 30 days, and not less than 14 days, prior to Election Day. Moreover, a substantial copy of this Ordinance and each voter information document attached as **Exhibit C**, including Spanish and Vietnamese translations thereof, shall be posted (i) at City Hall not less than 21 days prior to Election Day; (ii) at three additional public places within the City not less than 21 days prior to Election Day, (iii) in a prominent location at each polling place on Election Day and during early voting, and (iv) in a prominent location on the City's internet website not less than 21 days prior to Election Day. A sample ballot shall be posted on the City's internet website not less than 21 days prior to Election Day.

SECTION 8. As required by and in accordance with Section 3.009(b)(5) and (7) through (9) of the Texas Election Code, the City, as of the date of the adoption of this Ordinance, had outstanding an aggregate principal amount of debt equal to \$537,866,000; the aggregate amount of the interest owed on such City debt obligations, through respective maturity, totaled \$170,256,992.80; and the City levied an ad valorem debt service tax rate for its outstanding debt obligations of \$0.217575 per \$100 of taxable assessed valuation. Based on the bond market conditions on the date of the adoption of this Ordinance, the maximum interest rate for any series of bonds authorized at the Election is 5.55% (expressed as a net effective interest rate applicable to any such series of bonds). The bonds that are the subject of this Election shall mature serially or otherwise over a specified number of years (not more than 40 years from their date), as prescribed by applicable Texas law, though the City estimates that, based on current bond market conditions, such bonds will amortize over a 20-year period from their respective date of issue. The foregoing maximum net effective interest rate and estimated amortization period are only estimates, provided for Texas statutory compliance, and do not serve as a cap on the interest rate or the amortization period for bonds that are the subject of the Election.

SECTION 9. The Council authorizes the Mayor, the City Manager, or their respective designee, to negotiate and enter into one or more election agreements and/or similar contracts or agreements with Dallas County, Ellis County, and Tarrant County, acting by and through their respective Elections Administrator, as permitted and in accordance with the provisions of the Texas Election Code, as amended. In addition, the City authorizes the Mayor, the City Manager, or the respective designee of either of such parties to make such technical modifications to this Ordinance that are necessary for compliance with applicable Texas or federal law or to carry out the intent of the Council, as evidenced herein. To the extent that any duty or obligation of the City, in general, or any City official, in particular, is properly delegated to the Dallas County, Ellis County, and Tarrant County pursuant to an election agreement with such County, then the

County's carrying out those duties and obligations on the City's behalf pursuant to the terms of such election agreement shall be binding upon the City and are hereby determined by the Council to be evidence of the City's compliance with the provisions of applicable Texas law concerning the Election relative to the same. By incorporating all essential terms necessary for a joint election agreement, this Ordinance is intended to satisfy Section 271.002(d) of the Texas Election Code, as amended, without further action of the Council.

SECTION 10. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.

SECTION 11. All ordinances and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters ordained herein.

SECTION 12. This Ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

SECTION 13. It is officially found, determined, and declared that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Ordinance, was given, all as required by Texas Government Code, Chapter 551, as amended and as in effect on the date hereof.

SECTION 14. If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and this Council hereby declares that this Ordinance would have been enacted without such invalid provision.

SECTION 15. Pursuant to the provisions of Section 1201.028, as amended, Texas Government Code, this Ordinance shall be effective immediately upon adoption on the date shown below.




